- •15 minute walk: \$12.00/day or \$55.00 for the week \*
- •30 minute walk:\$16.00/day or \$75.00 for the week \*
- •1 hour walk: \$25.00/day or \$120.00 for the week \*

### **Pet Sitting Services**

(Includes food, water, potty and medication administrating. Play or walk included with Standard or Extended visits)

- •Standard pet visit (30-40 minutes): \$16.00/visit
- •Extended pet visit (40-60 minutes):\$20.00/visit \*\*
- Mini-Pet Sit (15-20 minutes):\$12.00/visit
- Puppy Potty & Play (15 Minutes):\$12.00/visit
- •Potty stop: \$8.00/visit\*\*\*
- •Cat only visit: \$12.00/visit

Rates are for standard business hours, M-F 8AM to 7PM. Weekly discounts are only honored with M-F consecutive Services, if cancellation of one or more stops occur in that week, client will be responsible for difference due without discounted rate for stops made during that week. Weekend and emergency service available by individual appointment only, In home consultation required prior to first visit, rates are subject to change.

# Pet Services GENERAL TERMS & CONDITIONS

### Payment & Additional Fees:

- (1) All payments are due **PRIOR** to services taking place. Delco Doggie may deny services if prior payment is not received.
- (2) All payments are to be in the form of CASH or CHECK only, all checks should be made payable to DELCO DOGGIE.
- (3) A "Return Check Charge" of \$25 will be incurred for all returned checks.
- (4) Client can choose to pay for multiple services at one time, in the event that a pre-paid service is cancelled, the client may request either an immediate refund or a credit towards future services. Refunds will not be given when requested more than 30 days after canceled services, however a credit towards future services will remain on your account for a period of 1 year.
- (5) There may be an additional late-night charge equal to time ½ of service for requested visits outside of 8AM-10PM business hours.
- (6) Emergency calls between Midnight and 7:00 A.M. are subject to a rate of **DOUBLE** the listed per visit rate regardless of the cause of the emergency.
- (7) All food and supplies will be provided by Owner. With multiple day sittings, Delco Doggie reserves the right to purchase additional food and/or supplies for animal(s). Owner agrees to reimburse Delco Doggie for said additional food and/or supplies immediately upon return.
- (8) During an in-home boarding agreement, clients returning home early **WITHOUT** notifying Delco Doggie, will also be charged for visits as contracted.

### **Emergency Medical Care:**

- (1) In the event of a medical emergency, Delco Doggie is authorized to obtain veterinarian care as we deem necessary for your pet.
- (2) Delco Doggie will make all attempts to use owner's requested vet, however if care is unavailable, we reserve the right to take your animal to another Emergency Veterinarian in the area.
- (3) Delco Doggie to incur veterinarian costs in the name of Owner. Owner agrees to hold harmless Delco Doggie from any liability arising from such veterinary charges. Owner agrees to reimburse Delco Doggie for any out-of-pocket expenses due to Emergency treatment.

### **Key Policy:**

- (1) Delco Doggie requires a copy of your house keys and/or any necessary access codes to be kept on file, prior to the start of service
- (2) An address will not appear on your key chain, a code will be assigned to your key to ensure utmost protection.
- (3) Delco Doggie will leave any retained Keys with owner at last scheduled appointment, if service is terminated prior to last scheduled appointment, there will be a return fee equal to one visit.
- (4) Delco Doggie reserves the right to make copies of provided keys without clients consent, soley for the purpose of use only by assigned sitter.
- (5) In the event that the owner accidentally, locks themselves out, feel free to call Delco Doggie for use of Key on file. Multiple occurrences are subject to service charge.

### **Cancellations:**

- (1) All cancellations for services scheduled between 10AM & 10PM must be made 6 hours prior to scheduled appointment, early morning services scheduled prior to 10AM must be canceled by 8PM the night prior. Delco Doggie reserves the right to charge the full cost of the scheduled appointment for any cancellations not made as directed above.
- (2) A cancellation fee equal to 2 visits will be charged for all Holiday cancellations within 48 hours of scheduled start time.

### **Inclement Weather:**

- (1) Delco Doggie DOES NOT cancel visits due to light rain, light snow or excessive heat or cold. If you would rather your dog not be exposed to this type of weather, please notify Delco Doggie as soon as possible.
- (2) In the event of inclement weather or natural disaster, Delco Doggie is entrusted to use best judgment in caring for your pets and/or home. Delco Doggie will be held harmless for consequences related to such decisions.

#### General Policies

- (1) Client understands that although one sitter is considered their main sitter, other sitters may complete services w/o advanced notice to client.
- (2) Should anyone working for Delco Doggie be bitten or otherwise exposed to any disease, ailment or injury directly from Client's animal or premises, it will be the client's responsibility to pay all associated costs and damages incurred by the victim.
- (3) Delco Doggie reserves the right to terminate this contract at any time before or during its term if anyone working for Delco Doggie does not feel comfortable or safe fulfilling the contract obligations. Delco Doggie will notify client immediately if this situation should arise, and work towards a solution if required.
- (4) Delco Doggie reserves the right to deny service to any pets who have a history of biting or fighting amongst themselves.
- (5) All pets **MUST** be current on all vaccinations prior to service.
- (6) Delco Doggie reserves the right to contact the local Animal Control Officer in the event a pet runs away.
- (7) A \$10/day holiday fee will be added to all major holidays and holiday weekends.
- (8) Delco Doggie will give a \$10.00 CREDIT for any referral entering into a pet sitting agreement for regular walking services.
